INFORMATION PURSUANT TO ARTICLES 13 AND 14 OF EU REGULATION 2016/679 (GDPR)

Pursuant to Articles 13 and 14 of EU Regulation 2016/679 (hereinafter, the 'Regulation'), and in relation to the personal data that Andrea Puccio (hereinafter, the 'Data Controller') will obtain during the video/audio/photographic recording activities referred to in the above release, we wish to inform you of the following.

1. Purpose of data processing. Legal basis.

The processing of your personal data is aimed at publishing your personal identification data (name, surname, job position) and your images, collected through the recording to which you have consented in the above release, for the purposes of corporate communication carried out by the Data Controller, as well as for the purposes of displaying audio/video material depicting you in relation to your participation in the individual event. The legal basis is Article 6(1)(a).

2. Data processing methods.

The processing will be carried out in an automated and/or manual form, in compliance with the provisions of Article 32 of the Regulation, by persons specifically appointed for this purpose and in compliance with the provisions of Articles 29 et seq. of the Regulation.

We would like to point out that, in compliance with the principles of lawfulness, purpose limitation and data minimisation, pursuant to Article 5 of the Regulation, subject to your free and explicit consent, your personal data will be stored for the period of time necessary to achieve the purposes indicated in point 1.

3. Communication of data.

Your personal data may be communicated to the data processors appointed by the Data Controller.

We inform you that the data collected will not be communicated without your explicit consent, except for necessary communications that may involve the transfer of data to public bodies, consultants or other parties for the fulfilment of legal obligations.

4. Provision of data. Refusal to provide data.

The provision of your personal data is strictly necessary for the fulfilment of the purposes indicated in point 1. The user's refusal to provide personal data will make it impossible to carry out the activities referred to in point 1.

5. Dissemination of images. Profiling.

Images depicting you will be disseminated through the Data Controller's digital and analogue communication channels (e.g. flyers, website, social media accounts). Your personal data will not be subject to profiling.

6. Transfer of data abroad.

Your personal data may be transferred to countries within the European Union for the purposes referred to in point 1. For the purposes referred to in point 1, your personal data may be transferred to third countries, in accordance with the provisions of Articles 45 and 46 of the Regulation.

7. Rights of the data subject.

The Regulation grants specific rights to individuals whose personal data is processed, including:

- (a) obtaining confirmation as to whether or not personal data concerning them is being processed and obtaining access to such data (Article 15 of the Regulation);
- (b) obtain the rectification of inaccurate personal data (Article 16 of the Regulation);
- (c) obtain the erasure of any personal data concerning them, in accordance with the right to be forgotten (Article 17 of the Regulation);
- (d) obtain restriction of processing by the Data Controller (Article 18 of the Regulation);
- (e) obtain their personal data in a structured, readable and understandable form, and have that data transmitted to another data controller without hindrance (Article 20 of the Regulation);
- (f) object to the processing of their personal data (Article 21 of the Regulation).

You may withdraw your consent given to the Data Controller at any time, without this withdrawal affecting the processing carried out by the Data Controller up to that point.

You may exercise your rights by sending a written request to the Data Controller, to the postal address of the registered office or to the email address milano@pucciopenalisti.it.

8. Right to appeal to a supervisory authority.

You have the right to appeal to the supervisory authority (Privacy Guarantor) at any time if you believe that your data is being processed in an improper manner.
